### Recreation I.D. Cards & Proof of Residency

El Segundo Residents must obtain a valid Recreation I.D. Card to register for classes or to reserve City facilities. Parents registering a minor must also have a current Recreation I.D. Card. Recreation I.D. Cards can be purchased at the Checkout Building or Clubhouse located in Recreation Park and require proof of residency.

#### *The following are acceptable proofs of residency:*

- Driver's License / California I.D. Card with a valid El Segundo address OR
- Two (2) utility bills from a residence within El Segundo with your name and address clearly listed on them. (P.O. Boxes are not accepted as a form of residency.)

#### **Cards are issued based on the following fees: Updated prices effective 9/1/14**

Youth (3-17 years old) - \$10

Adults (18-61 years old) - \$15

Infants (under 3 years old) - \$5

Senior Citizens (over 62 years old) - \$5

**Recreation I.D. Card fees are subject to change at any time.**

### Class Policies & Procedures

#### REFUND POLICY

Refund and/or Credit Requests must be made before the start of the third class for recreation classes and two-weeks prior to an Family Fun Trip. Family Fun Trip Refund Requests are processed at the Joslyn Center. A \$10 Administrative Fee will be charged for all refunds. Credit Requests can be made in lieu of refunds and applied to your account for future registrations. The \$10 Administrative Fee will be waived for Credit Requests.

#### CLASS INFORMATION

- The non-resident registration fee is 20% of the class fee (\$15 minimum).
- All students must be enrolled to participate in program.
- Siblings, friends, family members, etc. are not allowed to participate and/or assist (without proper registration) with set-up, instruction, and clean-up of the class.
- To obtain a space in a class, register early. Classes with low enrollment will be cancelled and participants will receive a full refund.

#### RETURNED CHECK FEE

A \$25 fee will be charged for all returned checks.
