Additionally, the public can comment on any public hearing item on the Agenda during the public hearing portion of such item. The time limit for comments is generally limited to five minutes per person.

Members of the public may request that items be placed on the Agenda by submitting a **Written Request** to the Planning and Building Safety Director at least ten days before the Planning Commission Meeting (by 10:00 a.m. the Monday of the prior week). The request must include a brief general description of the business to be transacted or discussed at the meeting. Playing of video tapes or use of visual aids may be permitted during meetings if they are submitted to the Planning and Building Safety Director a minimum of two working days before the meeting and they do not exceed five minutes in length.

- 2. **Environmental Assessment No. 730 and Subdivision No. 06-08**

The proposed project (site plan review) and building design is a modification to the previously approved development plans for Environmental Assessment No. 234 and Subdivision No. 90-6 for a four-unit condominium (Parcel Map No. 21918). The subdivision was recorded on August 15, 1991. The density of the project is one unit per 1,642 square feet and would comply with the Multi-Family Residential Zone. The proposed project consists of four two-story units located in a single building above a semi-subterranean garage. The project site is located in the Multi-Family Residential (R-3) Zone. The project site is located within the block bordered by Grand Avenue to the north, Franklin Avenue to the south, an alley to the west, and Whiting Street to the east.

RECOMMENDED ACTION: That the Planning Commission (1) open the public hearing and take testimony; (2) after considering the evidence from the public hearing, adopt Resolution No. 2623; and (3) alternatively, discuss and take any other action related to this item.
