The Planning Commission, with certain statutory exceptions, can only take action upon properly posted and listed agenda items.

The request must include a brief general description of the business to be transacted or discussed at the meeting. Playing of video tapes or use of visual aids may be permitted during meetings if they are submitted to the Planning and Building Safety Director a minimum of two working days before the meeting and they do not exceed five minutes in length.

To allow the placement and construction of a maximum of 27 signs over 6 feet in height within the Edge at Campus El Segundo project encompassing 17 buildings on the two blocks bounded by Maple Avenue, Nash Street, Douglas Street, and Atwood Way.

The applicant requests an Administrative Use Permit to allow for the placement and construction of the following signs on the two blocks bounded by Maple Avenue, Nash Street, Douglas Street and Atwood Way: six (6) vehicular entry monument signs, not to exceed 7'-10" in height each; two (2) transit information directory monument signs, not to exceed 7'-5" in height each; two (2) retail monument signs, not to exceed 20'-0" in height each, and a maximum of seventeen (17) tenant pedestrian monument signs (optional), not to exceed 7'-0" in height each. The six vehicular entry monument signs will generally be placed along the street frontages on Nash Street (1 sign), Maple Avenue (2 signs), Douglas

Street (1 sign) and Parkview Drive North (2 signs). One of the two transit information directory monument signs will be located in the plaza area at the northwest corner of Maple Avenue and Douglas Street and the other transit information directory monument sign will be located in the plaza area on the north frontage of the 2121-2125 Maple Avenue building. The two retail monument signs will be placed in the vicinity of the northwest corner of Maple Avenue and Douglas Street. The tenant pedestrian monument signs will be dispersed throughout the project site generally in front of the building entrances facing the parking areas with one sign per building except that building 8 and building 13 would be permitted 2 signs per building.
