The Information Technology (IT) Acting Manager is in the process of hiring some special consultants to handle the backlog of projects. He has told us that installing Encore is a top priority when he can bring the consultants onboard soon. After it is installed, Mark will do a demonstration to the Board of the new catalog and all the new features.
