The Planning Commission, with certain statutory exceptions, can only take action upon properly posted and listed agenda items.

Unless otherwise noted in the Agenda, the public can only comment on City-related business that is within the subject-matter jurisdiction of the Planning Commission and items listed on the Agenda during the **Public Communications** portion of the meeting. Additionally, the public can comment on any public hearing item on the Agenda during the public hearing portion of such item. The time limit for comments is generally limited to five minutes per person.

Members of the public may request that items be placed on the Agenda by submitting a **Written Request** to the Planning and Building Safety Director at least ten days before the Planning Commission Meeting (by 10:00 a.m. the Monday of the prior week). The request must include a brief general description of the business to be transacted or discussed at the meeting. Playing of video tapes or use of visual aids may be permitted during meetings if they are submitted to the Planning and Building Safety Director a minimum of two working days before the meeting and they do not exceed five minutes in length.

A Request for a Type 47 Alcohol License for a New Restaurant

The applicant requests the approval of an Administrative Use Permit for an alcohol license to sell beer, wine and distilled spirits for on-site consumption (Type 47 Alcoholic Beverage Control license) at a new restaurant currently under construction at a new commercial shopping center located at 307 North Sepulveda Boulevard in the General Commercial (C-3) Zone. The restaurant will be approximately 2,500 square feet and include a 200 square-foot outdoor patio. The indoor dining area will contain 42 seats and the outdoor patio area will contain a maximum of 13 seats.
