El Segundo Police Department New Fee Schedule

On August 17, 2010, City Council passed and adopted City Resolution No. 4674 increasing permit fees for some services, discontinuing others and no changes for some. The full fee schedule is attached.

One of the significant changes that would impact businesses and residents are the fees associated with false alarms for both permit and non-permit holders.

Application for alarm permit - No charge Violation for non-alarm permit - \$160.00 First 3 false alarms in a fiscal year - No charge

(October 1-September 30)

4th false alarm - \$200.00 5th false alarm - \$300.00 6th and subsequent false alarm - \$400.00

A 30 day grace period has been implemented, but effective November 1, 2010, non permitted violators will be charged the appropriate fee.
